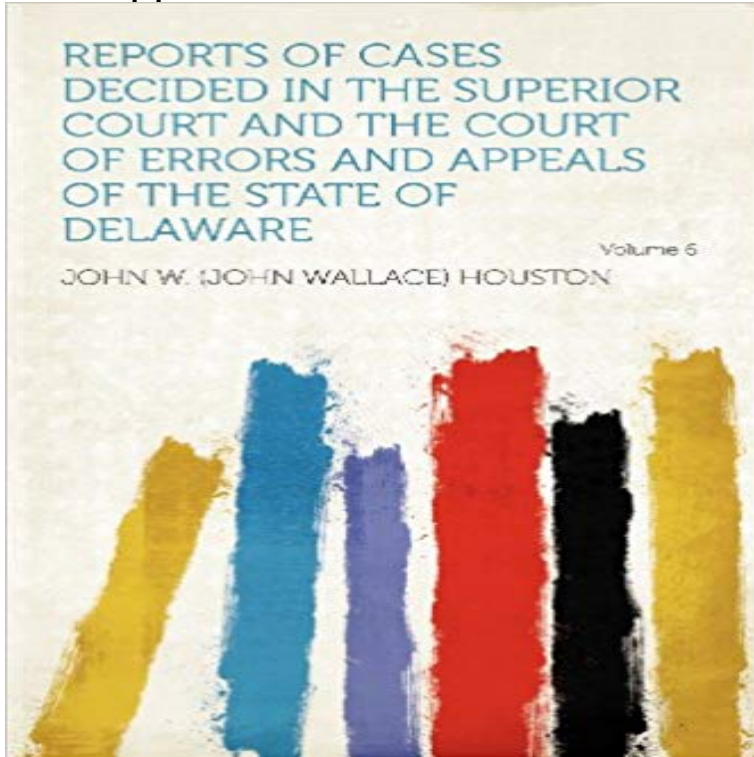


# Reports of Cases Decided in the Superior Court and the Court of Errors and Appeals of the State of Delaware Volume 6
