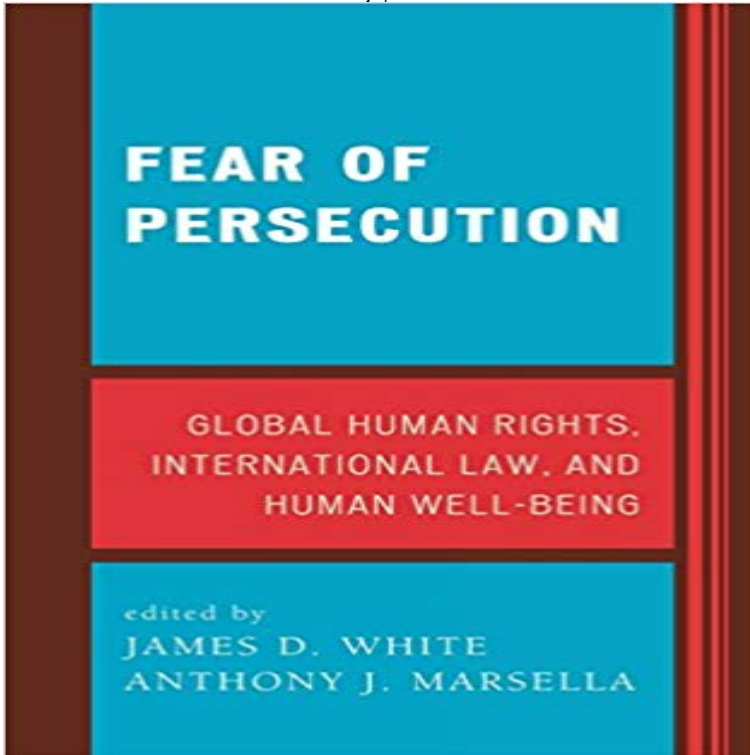


Fear of Persecution: Global Human Rights, International Law, and Human Well-Being
