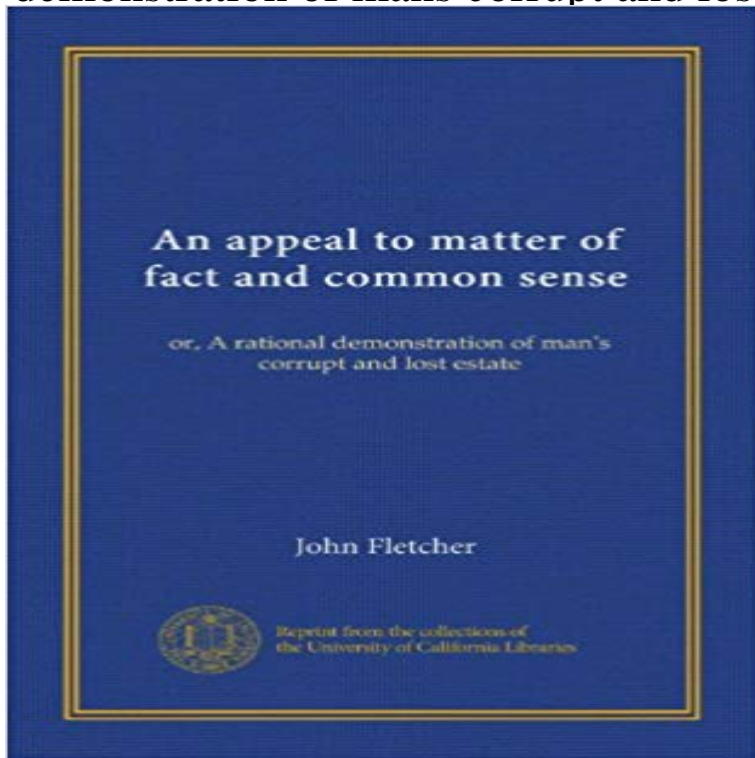


# An appeal to matter of fact and common sense: or, A rational demonstration of mans corrupt and lost estate
