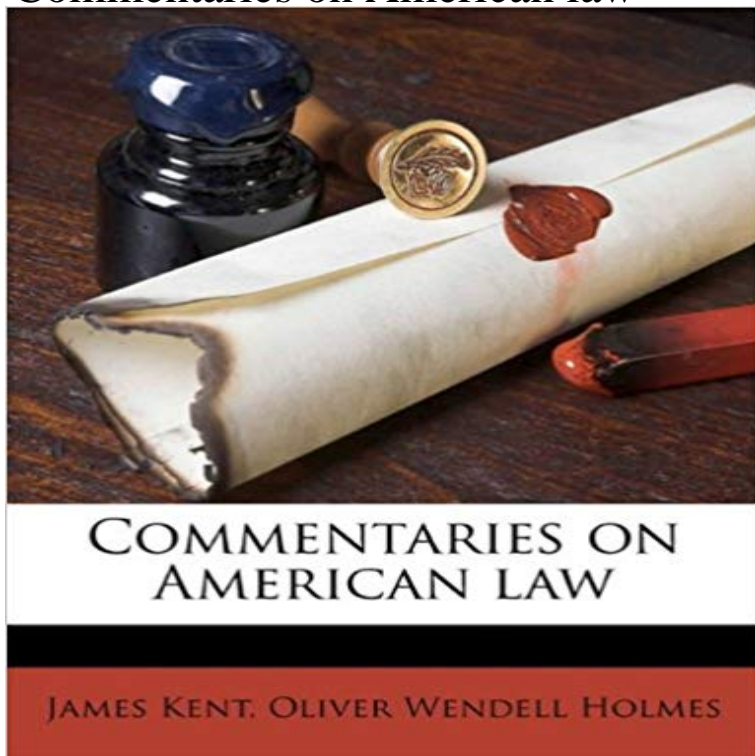


## Commentaries on American law
