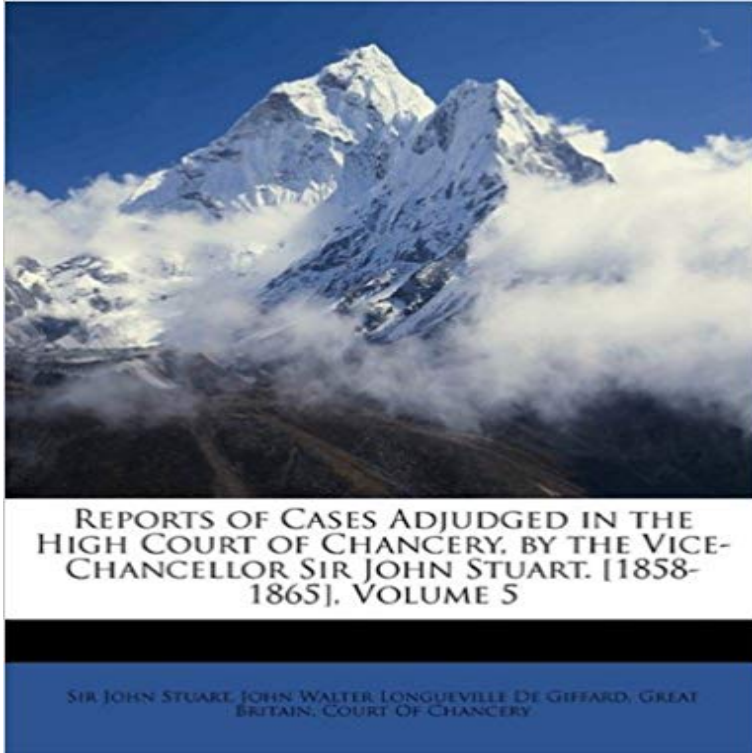


## Reports of Cases Adjudged in the High Court of Chancery, by the Vice-Chancellor Sir John Stuart. [1858-1865], Volume 5
