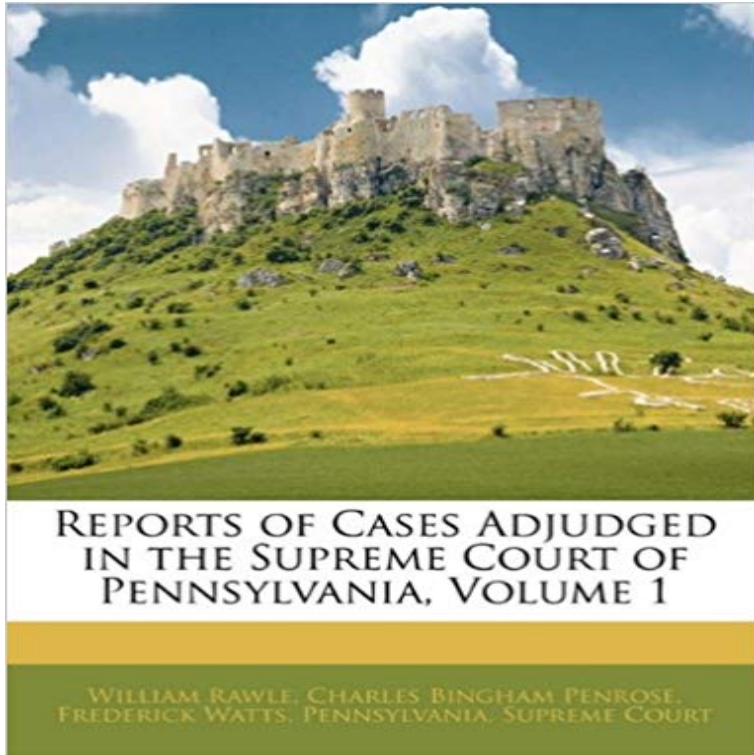


# Reports of Cases Adjudged in the Supreme Court of Pennsylvania, Volume 1
