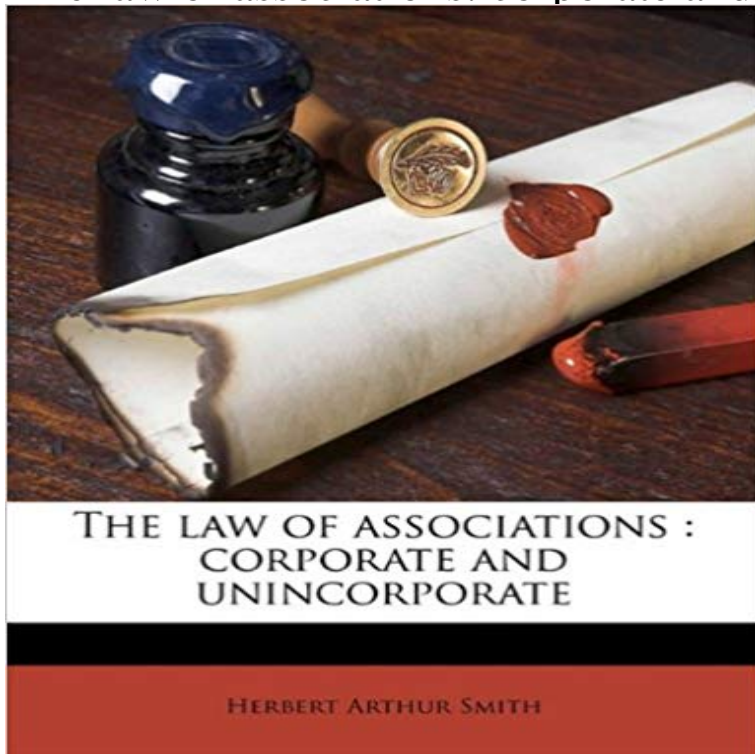


## The law of associations: corporate and unincorporate
