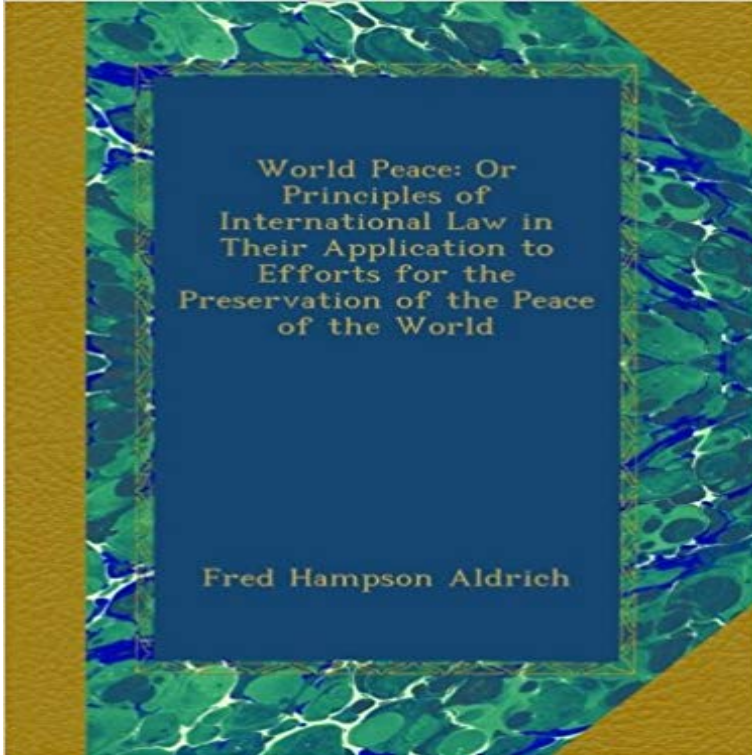


# World Peace: Or Principles of International Law in Their Application to Efforts for the Preservation of the Peace of the World
